***CSOs For Good Governance:
Enhancing civil society's contribution to governance and development processes in
Trinidad and Tobago (CSOs4GoodGov)***

1 Introduction

This report presents the outcomes of the SDGs Catalysts Network's 10th Quarterly meeting held on February 13th, 2020 at Caribbean Natural Resources Institute's Office, Barataria, Trinidad. The report provides an overview of the participants, objectives and methods, and recounts the main activities of the CSOs4GoodGov project. The following key items were addressed in the meeting:

- progress reporting by component leads including updates on final actions and activities for Catalysts participation and inputs
- sharing latest news on government preparations for the Trinidad and Tobago (T&T) Voluntary National Review (VNR) 2020 and related updates on the delivery of the CSO shadow report on SDG 13 Climate Action;
- two facilitated sessions to engage Catalysts in a final review of the project results

Participants:

Twenty-three (23) persons attended the meeting, including participants from 16 SDGs Catalysts Network member organisations.

2 Meeting Objectives

The specific meeting objectives were:

1. To share CSOs4GoodGov progress reports and provide Catalysts with updates on any final actions and activities for their participation and inputs
2. To update Catalysts on progress with the CSO shadow report on SDG 13 Climate Action and discuss next steps/actions
3. To facilitate participation of Catalysts in final project monitoring and evaluation exercises using a. outcome mapping and b. reflecting on capacity building
4. To facilitate sharing on next steps and actions beyond the project

3 Methodology

Component leads made short verbal presentations to share progress reports.

CANARI made short presentation on progress of the CSO shadow report and facilitated plenary sharing and discussion by Catalysts on the recent consultation sessions held by the Ministry of Planning and Development (MoPD) for the T&T VNR.

CANARI engaged Catalysts in an interactive outcome mapping exercise using the project monitoring and evaluation (M&E) framework. In plenary, Catalysts were encouraged to share feedback on the outcomes and indicators of change or progress markers (expect to see, like to see and love to see) included in the framework, noting especially any evidence that the outcome had been achieved.

Veni Apwann also conducted an interactive exercise to engage Catalysts in a final review of the capacity building implemented under the project. Catalysts were facilitated to utilise available materials to visually share about what they felt was the 'most significant change' under the project.

4 Review of Key Sessions

This section covers review of main discussions and findings from each of the key meeting sessions.

4.1 CSOs4GoodGov Progress Reports & Updates

United Way TT (UWTT):

- The EU has proposed that UWTT organise a mini symposium to share lessons, results and achievements. More information will be shared on this soon.
- UWTT is preparing a summary report on all the advocacy actions funded by small grants under the project.
- Under the project, a total of 19 grants were disbursed over 5 rounds to 12 participating Catalyst organisations. (This included disbursements of TT\$50,000 each in rounds 1 and 5, TT\$20,000 each in round 2, and TT\$15,000 each in rounds 3 and 4)
- UWTT is continuing work on the NPO pilot online registration portal to support CSOs in filling and submitting their NPO Risk Assessment Forms. UWTT will continue to share any learnings and experiences from interacting with the Registrar General's Office so that NPOs could be better prepared when submitting their documents.
- UWTT along with CAISO attended an international not-for-profit conference in December 2019. This was useful in understanding the scope of the Financial Action Task Force (FATF) recommendations to combat money laundering and terrorist financing. Civil society action around the NPO Bill 2019 was highlighted and it was also a useful opportunity to learn about how civil society in other states were organising/taking action.

Veni Apwann (VA):

- VA will be conducting a final interactive evaluation on capacity building this meeting and will pull together a final report on success of capacity building interventions, including examples of demonstrated increase in capacity of Catalysts.
- VA noted complementary work being undertaken by the Transforming Each Other's Advocacy (TEOA) project in partnership with Sexual Culture of Justice, The Cropper Foundation and The Lloyd Best Institute from September 2019 to March 2020.
 - The Transformational Advocacy Action Learning Group was continuing to engage and expected to produce case studies on their advocacy work which will be shared for upload to the SDGs Knowledge Platform.
 - A support group was formed and was proving highly useful for providing those heavily involved in advocacy work with a means to decompress.

CANARI:

- Significant progress is being made on the CSO Advocacy Toolkit. The Toolkit was being designed to be broadly applicable to CSOs working on SDGs across the region. A draft is expected from the consultant, Michele Matthews-Morancie by February 17, 2020. Michele is very familiar with the project, as well as the specific rationale and needs for the toolkit, having been part of the Capacity Building Working Group (CBWG) convened under component 3 of the project.
- The T&T Government held consultations in December 2019 and is expected to continue having consultations for preparation of the VNR. The VNR consultant indicated there would be further focus groups; CANARI will share information to Catalysts as it becomes available.
- CANARI had been in touch with UN ECLAC and was actively interested and seeking information to try to attend the 4th Meeting of the Forum of the Countries of Latin America and the Caribbean on Sustainable Development. The meeting is carded for March 31, 2020. The meeting will be held after the project's official close but was identified as a strategic opportunity to share work done under the project, especially the collective civil society effort to develop a shadow report on SDG 13 Climate Action.
- CANARI continues to manage the SDGs Knowledge Platform; submissions were being received from regional CSOs through other projects CANARI is managing.

4.2 Developing a CSO Shadow report on SDG 13 Climate Action

CANARI shared a review of the process for developing the CSO shadow report, and main findings and recommendations to date.

- CANARI recapped the opportunity to develop a civil society report for the VNR, noting the objectives were to share civil society perspectives, priorities, recommendations. The initial approach was to have Catalysts report on different SDG themes using a standard template, however recognising challenges including with available time, capacity and resources, CANARI proposed focusing on climate change as cross cutting development issue. The feedback was that this was a useful approach that gave a lot of depth by engaging CSOs working across sectors for inputs.
- CANARI is working to complete the draft report to share for review by end of February 2020. CANARI noted the 5 SDG cluster groups at the December 2019 consultation meeting were able to provide useful insights and sectoral analysis on climate change impacts, map priorities to address climate change, assess progress on the priorities using a stoplight approach, and generate overarching recommendations for integrated action. Twenty-five preliminary priorities across sectors were identified. See copy of CANARI's supporting presentation for the session [here](#).
- CANARI is currently conducting additional consultations with CSOs in T&T via an [online survey](#) launched in January 2020 and targeted telephone interviews with key CSOs who were not at the December 2019 consultation meeting. The results will be collated and included as part of the draft report.

CANARI also engaged Catalysts in discussions on next steps for the report. The following main discussion points were noted:

- A suggestion was made to consider expanding the perspective in the report beyond civil society, however it was agreed the report will focus on CSO voices as civil society representation was already limited
- Catalysts need to use the VNR consultation meetings by the MoPD to influence government; the government consultant has already engaged CANARI and other CSOs for VNR inputs.
- CANARI has been engaging the MoPD and expressed interest in having a civil society representative on the T&T national delegation to attend the UN High-level Political Forum; CANARI has been exploring resources to be able to attend and encourages other CSOs to do the same. Catalysts in the meeting agreed CANARI would be a good CSO delegate on the national delegation.
- A meeting with Independent Senators and possibly even the Senate President is being pursued for late May 2020. This was identified as a good opportunity to highlight the report, including with support from CSO representatives from the 5 SDG cluster groups convened at the December 2019 consultation meeting. It was further noted that Joint Select Committees of Parliament do accept feedback/comments/input via Twitter.
- The report includes recommendations not identified by others or discussed in detail at the MoPD's SDG 13 focus group session held on February 7th, 2020, so there was opportunity to add value.
- There remains a need to drill down with the public on how the SDGs impact their daily lives; a broad recommendation was made to increase public literacy on SDGs. The report is a starting point.

4.3 Participatory monitoring & evaluation of the CSOs4GoodGov project

4.3.1 Outcome mapping

CANARI facilitated a final participatory monitoring and evaluation session with Catalysts focused on outcome mapping. This session formed part of the final evaluation on the performance of Catalysts under the project.

Outcome statements developed at three levels (expect to see, like to see, love to see) as part of the project M&E framework were referenced for the exercise. The presentation used to facilitate the discussion can be accessed

Catalysts were encouraged to collectively analyse the various outcome statements and highlight any changes at organisation level, as well as pinpoint evidence of achievements against the outcomes. During the review, Catalysts were able to draw out some examples and stories of progress made, results achieved under the various project outcomes and any challenges faced. Results of the assessment are shared in the Tables 1-4 below.

In the absence of a clear government mechanism for engaging on the SDGs, CANARI as the convener of the SDGs Catalysts Network engaged Catalysts and wider CSOs in T&T to input into the VNR consultations and in developing a civil society shadow report. Catalysts have also actively engaged other Catalysts and CSOs in advocacy to government (see campaigns mentioned above) and shared lessons and other feedback on the process and results

With respect to Outcome 5 on overall project management, significant results were achieved at the 'expect to see' and 'like to see' levels

- Expect to see: Project component leads actively led the planning, monitoring, evaluation and communication of the CSOs4GoodGov project with inputs from Catalysts at Quarterly Catalysts meetings and as otherwise needed. Participatory approaches were used to engage Catalysts in the planning and execution of key activities under the project. Participatory monitoring and evaluation using the project M&E framework was conducted on an annual basis, including via survey and facilitated sessions in Catalysts meetings. Few CSOs engaged in active documented communication about the project on their own, but more readily participated in actions led by the component managers.
- Like to see: It was noted that Component leads have supported each other to develop and refine systems and structures for collective working under the CSOs4GoodGov project and to ensure synergies. Over the three years, several improvements were made to support effective collaborative project management including regular check-ins amongst project leads for planning and coordinating actions across components; and participatory budgeting especially during annual work-planning.

At the 'Love to see' level, it was noted that actions were starting but more work was needed. CSOs were beginning to develop other collaborative projects on the SDGs and applying lessons on collaborative working, but more time is needed to see how effectively CSOs are able to apply knowledge and best practices for project management to other projects.

4.3.2 Reflecting on capacity building under the project

Veni Apwann facilitated a final M&E session with Catalysts focused on capacity building implemented under the project. Catalysts were asked to reflect and share the most significant changes for themselves as individuals and as organisations over the course of the project, as well as lessons learnt. Catalysts were asked to be creative and utilise available materials to visually share their feedback.

Common themes expressed by the Catalysts included, increased collaboration, trust and partnerships. Opportunities for networking and broadened awareness of the SDGs in general and the need for integrated working in particular, were highlighted. There was also evidence of growing focus on and linkages between various environment and rights-based SDG thematic areas. A particularly notable moment during one Catalyst's share, was the evidence of the development of respect even when initial strong differences of opinion existed in Year 1 of the project.
