





# **Development of a Stakeholder Engagement Strategy for the OECS**

**PROJECT BRIEF** 

## Background

The Caribbean Natural Resources Institute (<u>CANARI</u>) is providing technical assistance to the Organisation of Eastern Caribbean States (<u>OECS</u>) Commission to develop a strategy that can guide its engagement of key stakeholders in the civil society and private sectors to contribute to efforts aimed at the management and sustainable use of marine and terrestrial biodiversity in the OECS. The Stakeholder Engagement Strategy developed will fulfil a mandate from the OECS Council of Ministers for Environmental Sustainability.

## **Project in brief**

Outcome: Strategy developed for effective engagement of civil society and private sector in

management and sustainable use of marine and terrestrial biodiversity in the OECS.

**Budget:** €20,000

**Duration:** June 2021 to September 2021

The Strategy will be informed by policy directions and requirements for stakeholder engagement in environmental management as described in OECS strategies and plans, including under the Treaty of Basseterre (1981) and The Revised Treaty of Basseterre (2010), the St George's Declaration of Principles of Environmental Sustainability, the OECS Development Strategy and specific strategies and plans developed by the Environmental Sustainability Division. This work is part of the OECS Commission's BioSPACE project (OECS/BioSPACE/2021/SER\_02) funded by the European Union.

#### Focus of the Strategy

The Strategy will provide guidelines for engagement of civil society (including national and community-based groups) and private sector stakeholders (including resource users, user associations and naturebased micro-enterprises). It will be used by public sector agencies in the OECS, the OECS Commission, and their partners working on biodiversity and ecosystems management in the OECS region. It will cover all members of the OECS: Anguilla, Antigua and Barbuda, the British Virgin Islands, Commonwealth of Dominica, Grenada, Guadeloupe, Martinique, Montserrat, St. Kitts and Nevis, Saint Lucia, St. Vincent and the Grenadines.




